## Hazardous Soil FEES, TAXES AND INDEMNIFICATION

### **High State Fees**

The State of California's DTSC recently changed the collection of Hazardous Waste Fees from waste generators.

In January of 2022, SB158 significantly changed the existing California Hazardous Waste fee structure. *The state replaced the old tiered fee with an annual maximum of \$100,000 with a new fee of \$49.25 with no annual limit for every ton of hazardous waste landfilled.* 

A 10,000 ton CALHAZ Class 1 offhaul now has a generator fee of \$492,500. The fee for a 20,305 ton offhaul is over \$1,000,000.
